Terms and Conditions

- All Memberships are valid for a period of twelve months (or six months if paid between October to March) until the 30th June each year.
 - From July to September Applicants must pay the full annual subscription fee upon application. From October to March it is possible to pay half the annual subscription fee for Membership, which will be valid until 30th June. From March until June 30th it is possible for an applicant to pay the full annual subscription fee for Membership, which will be valid until June 30th the following year.
 - One person per membership is entitled to be a volunteer for no additional cost.
 - Application is subject to approval by the Board at the next occurring Board Meeting.
 - Unless membership is renewed by 30th June the following year, membership will cease.
 - No applications will be considered by the Board 21 days prior to a General Meeting or Annual General Meeting
 - The Membership and entrance fee is non-refundable once membership has been accepted by the Board.
 - Community Members are entitled to vote (one single equal vote) at the AGM, however you must be a member at least 60 days prior to the AGM to exercise voting rights.
 - Community Members are subject to other rules as specified in the Company's Constitution (disciplining, penalties, right of appeal etc.)
 - In the case of an Applicant who is an incorporated body, a certified copy of the Constitution and a Warranty that the Applicant is duly incorporated at the time of application is required with the application.
